- 1.0 The bidders should submit their bids, complete in all respects, in two separate sealed envelopes. Envelope No.1 & 2 both of which should be placed inside a third envelope marked **"Tender for CCTV SURVEILLANCE SYSTEM & OTHER RELATED DEVICES "**. Name and address of the company must be clearly visible on the envelop
- 1.1 **Envelope No.1** should be sealed and marked as **"Technical Bid"** and should contain duly filled in and complete Technical bid with supporting documents, as per clause 2.0 (MQC) of this Tender document.
- 1.2 **Envelope No.2** should be sealed and marked as **"Financial Bid"** and should contain duly filled in and complete financial offer. The bids will be evaluated on the basis of technical details given in the Envelope No. 1 & rates quoted in the financial bid in Envelope No. 2 for CCTV Surveillance System & other related devices..
- 1.3 Technical Bid (envelope No.1) shall be opened first. The Financial Bid (Envelope No. 2) of those bidders whose Technical Bids are found complete and valid in all respect shall be qualified for Opening of Envelope No. 2.
- 1.4 Bids received shall be opened in presence of Authorized Officials of VAMNICOM. If any of the required papers / certificates as specified in the Tender are not included or not in proper order, the said bidder will be treated as disqualified.

### **3.0 General Terms and Conditions**

- 3.1 The price quoted shall be firm and shall either be an all inclusive rate or the incidental charges, taxes, insurance freight, packing and forwarding charges should be indicated separately against each heading. For imported items, FE as well as equivalent Indian currency should be quoted.
- 3.2 Two separate bids shall be submitted for the items i.e. one Technical Bid containing the complete specifications and features and the other Financial Bid quoting as at S.No.I.
- 3.3 Complete specifications of the item shall be given. Necessary technical literature and catalogues shall be enclosed. Any deviation from the enquiry specifications shall be clearly stated in the quotation.
- 3.4 Director, VAMNICOM, Pune-7 reserves the right to reject any or all the quotations wholly or partly without assigning any reasons and no correspondence in this regard will be entertained.
- 3.5 The items supplied/service provided will be subjected to an inspection, acceptance and installation at this office premise.
- 3.6 The 10% of the total Hardware cost will be retained for a warranty period of 05 years. The said

- amount will be forfeited besides penalty as fixed by VAMNICOM in case the company opts out of warranty period.
- 3.7 The Payment shall be made against pre-receipted bill within 30 days of its presentation.
- 3.8 The warranty for all devices, equipments, cabling, networking etc., will be for a period of **FIVE YEARS** from the date of successful deployment and operationalization of entire system certified by VAMNICOM.
- 3.9 In case, the successful bidder fails to deliver the item/does not provide satisfactory service after sale within the warranty period, or does not install the CCTV Surveillance System successfully, the performance guarantee will be forfeited.
- 3.10 In case of non supply of the item within the prescribed period, Director, VAMNICOM, Pune – 7 reserves the right to cancel the order without any notice to the supplier.
- 3.11 The supplier will also be liable to pay liquidated damages as prescribed by Director, VAMNICOM, Pune - 7.
- 3.12 The services shall be rendered in such a way that the breakdown time does not exceed a calendar day, failing which the Director, VAMNICOM reserves the right to impose a penalty. In case of substitution with standby equipment, the penalty is not applicable.
- 3.13 VAMNICOM has no objection for complete access to the systems and provide the necessary assistance to enable you company to meet its obligation under this contract.
- 3.14 The supply and fitment of parts will be at company's cost. The defective part or parts removed from the equipment in this connection shall immediately become company's property and the replaced part(s) fitted back in the equipment shall immediately become VAMNICOM's property.
- 3.15 In the event of any dispute or difference arising between company and VAMNICOM with regard to this contract, the matters under dispute shall be referred to a single arbitrator mutually agreed upon or two arbitrators separately appointed by company and VAMNICOM or their umpire in accordance with The Arbitration and Conciliation Act 1996 or any new enhancement replacing, extending, or modifying the same. The arbitration proceedings shall take place in Pune.
- 3.16 Either party can terminate the contract at any time by giving THREE months notice in writing. However, the company will have binding of payment for pro rota charges as fixed by VAMNICOM.
- 3.17 It may also be noted that in case of bidder backing out in mid term without any explicit consent of VAMNICOM, the company has to remit recovery at higher rates, vis-à-vis, those contracted with it, which may have to be incurred by VAMNICOM on maintenance of CCTV Surveillance System.
- 3.18 Three months prior to expiry of the warranty period of 05 years, VAMNICOM may call for fresh Tenders or may renew the existing contract. The maintenance contract will be renewed on or before the expiry date. Renewal should be proposed by either of the interested party to the other at least 3 months in advance. Acceptance of the same will not be binding on either side.
- 3.19 The successful bidder should provide standard format of **Service Level Agreement (SLA)** to ensure smooth and trouble free functioning of the Hardware, Software, Networking and other equipment's. It will be binding upon the bidder to enter in to mutually agreeable Service Level Agreement with VAMNICOM while accepting the contract. The stamp paper of Rs. 500/- has to be obtained by vendor for signing the agreement.
- 3.20 VAMNICOM, Pune reserves the right to accept or reject any or all tenders without assigning any reasons thereof.

#### 4.1. SCOPE OF WORK:

- Objective of work is supply, installation, configuration, testing & commissioning of CCTV system at VAMNICOM campus for monitoring general surveillance activity.
- Scope of work includes supply, installation, configuration, testing & commissioning of ordered Equipment / Material at the site.
- All the items should be with standard necessary accessories such as screw, clamp, cable tie, coupler, marking tags/sticker etc.
- All the required tools and equipment's such as millimeter, spanners, etc. shall be arranged by tenderer. However electrical supply will be provided by VAMNICOM.
- Testing, commissioning and handover of ordered material as per BOQ.
- The work shall be under warrantee and support for five years. **Under warrantee and support period, compulsory monthly preventive maintenance of CCTV system during last week of calendar month has to be ensured by the tenderrer.**
- All complaints shall be attended and rectified within 24 hours from the time of complaint registered with your office (communicated through telephone / fax / email / letter).
- In case the fault cannot be rectified onsite and the system/equipment needs to be taken outside, bidder shall provide a standby system/equipment of equivalent specifications and restore the system at own cost within 36 hours.
- If, fails to rectify the complaints within stipulated time or monthly preventive maintenance, 0.2 % of the total contract value as penalty per day shall be recovered from Performance Guarantee deposit.
- Bidder shall be responsible to impart train to the existing technical staff for maintenance and operations of supplied equipment's.
- The payment shall be made on actuals and as per the rate quoted for the various items / devices for which per unit rate has been requested.
- Bidder has to quote rate against all the items.
- Bidder has to arrange transport facility for carrying out the work.
- Cabling work must be done neatly & as per industry specified standards.
- Supply of the required hardware & application software has to be ensured.
- Pole erection has to be undertaken by bidder in consultation with technical team of VAMNICOM.
- Trenching for communication & Power cables and laying of these cables. Digging (depth 1.5 Mtr) & refilling of soil and tar/concrete.
- Laying Earthing & Civil works has to be carried on as per actual requirements.

- Before excavation, the cable route shall be scanned with cable damage avoidance tool, which shall be monitored by VAMNICOM, Any damage to the existing utilities and existing electrical cables / communication cables etc. shall be repaired by tenderer at their own cost.
- Any damage to the existing flooring / walls etc. shall be repaired by tenderer at their own cost.
- Cable shall be buried 90 cms below the normal ground level. Cable route marker & detailed diagram of cable route map indicating the lengths, termination of cables with connectors, labeling and marking must be done as per industry specified standards.
- Installation & Commissioning of the surveillance system along with network including OFC termination, switches, display monitors and other accessories
- Network diagram has to be prepared by bidder based on the actual connectivity laid down.
- Testing & Trial run has to be done in presence of VAMNICOM team.
- Imparting Multi-level Training (shall include technical / Operator training)
- Supply and erection of necessary self-supporting poles, fixtures, brackets and accessories for the mounting of cameras on tower/poles at the above site. Tenderer shall supply and install necessary fixtures & protectors for earthing & lightning protection to protect the equipment from lightning / high voltage surge and other interference.
- Supply and installation of cameras, networking and associated accessories
- Extension of Power cables, Ethernet cables, etc. As required for placing cameras location and to other buildings through trenches or in ducts, as per industry specific standard.
- Supply, routing, installation and termination of required cables at VAMNICOM shall be under Tenderer's scope.
- Tenderer's scope includes all software license, up gradation packages (including installation, testing of software, etc. all complete) till warranty period of five years without any cost implication during warranty period.
- The tenderer shall have the responsibility to gather information for complete system design and detailed Engineering to meet the overall system availability objectives. Tenderer shall visit VAMNICOM, with prior permission, to acquaint themselves with the exact site requirement & site conditions.
- The solution provided by the bidder should have the provision for scalability for future integration with other security system if required.
